Appendix: REPORTS

CRS Report

2,400+ superbly prepared and high-gloss printed copies of NRA Newsletter (Autumn edition #182) were collected 27 Oct onwards by ARSs and distributed via our army of dedicated RSs, with a compressed .pdf version distributed to Carole Holton for onward electronic distribution to some further 180 NRA members in Dene Road RA who requested a digital version only.

Subs have continued to come (as evidenced in the Finance report) – via RS's cheques for subs they have collected, with an increasing number of members (and some RSs) paying on-line.

Whilst the growing popularity of on-line payments is to be welcomed, with inconsistent references these often take detective work to enable entry in the existing members db and add a lot of extra manual work – one of many reasons why that has become "unfit for purpose".

Work over a year ago on a new custom db design had faltered, so I investigated whether a commercially available db would suit our needs. The most potentially suitable membermojo (mmjo) appeared to do most of what we need, and during the summer we embarked on a free 60-day evaluation, which was extended for two further 30-day trial periods.

As their response to technical support questions raised had been prompt and germane to our needs, the decision was taken at the end of November to purchase a one-year license, and to start sequentially larger trials before going live to fully replace our existing system.

This has, and will continue to, involve extensive "data-cleaning" in the transfer of info from the present db, which has become riddled with errors and incorrect entries.

We have had technical advice in this from members with suitable IT expertise, and I am glad to report that one in particular (Rajen Shah) has undertaken to continue with an overview of our use of mmjo – the first will be to use it to send "alerts" to members on items of urgent or local interest.

A demonstration of mmjo capabilities for our needs will be given in the New Year when we hope to start using it as one method of reminding for and collection of subs as we move further towards electronic payment.

Health Report

Return to 'masks in all areas of Hillingdon Hospitals NHS Trust hospitals'

The NHS in North West London is under significant pressure at the current time with a high number of very sick patients and they are working at full capacity.

They are, therefore, once again asking patients, visitors and staff to wear masks in all areas of their hospitals, sanitising hands before putting on a mask, and disposing of masks in bins.

As always, the main focus is on keeping people safe and ensuring that everyone receives the care they need as soon as possible. There may be short-term changes to how they manage patient flow in their services, including infection prevention and control.

During this time, they are asking staff and patients to inform others if there has been any contact with someone who has flu or Covid-19. Patients may be moved during their stay to create beds for new admissions.

Everything is being done to ensure that people are not exposed to additional risk when in hospital.

In addition, they ask you to help them where possible by only visiting if you are well and symptom free, remembering to wash your hands regularly and minimising the number of people visiting at any time.

Obtaining a Tree Preservation Order: Some residents have asked how a TPO request can be raised to protect trees and the answer is that residents can apply for particular trees to have a TPO put on them by contacting Hillingdon Borough Council. Just email trees@hillingdon.gov.uk with details of the tree(s) location, supporting pictures, and reasons for the request. Following receipt of the request a short investigation normally should follow before any advice or ruling is provided.

118 High Street Northwood: An issue raised by the landlord regarding bins storage outside his property was passed to the Council by email to review and copied to Cllr Henry Higgins. Regretfully the Hillingdon contact centre refused to work from an emailed advice and required their web based form to be completed (it took 15 minutes as it is complex to fill) and eventually that submission was accepted and a reference 1598 - 0206 - 6534 - 9959 issued.

47, **48**, and **49** Northwood Way, HA6 1AU: A ditch and broken bollard matter has been raised by a resident – yet to be dealt with.

Old Police Station, Northwood: a detailed email was sent to Cllr Henry Higgins re the anticipated heightened traffic volumes and environmental issues as expressed by many residents that would be the likely outcome should planning permission be granted for the development here by Iron Age.

Northwood SNT

We welcome our new sergeant, Gareth Blackburn, and our new PC Mike Fowler.

However, our Northwood sergeant is shared with Northwood Hills. Our new constable still has a learning curve. So, John is the only keeper of the recent history and knowledge in our ward. In short: we are understaffed.

Both Sir Mark Rowley and PM Rishi Sunak have promised 20,00 additional police officers across England and Wales. By spring. I doubt many of them will be assigned to Northwood or its immediate neighbours. If we wish to maintain Northwood as a relatively low-crime area, there is more for the ward panel to do.

New Panel Members

We welcome Dilsha and Nagad, our new Northwood College students. Katie Allchorne, deputy head, will also attend our first meeting of the year.

Welcome to Malcolm Lucas, who has kindly volunteered to take our minutes. Malcolm is also a member of the Hillingdon Independent Advisory Group and will give us a brief overview at our next meeting.

Welcome to Keith Weston, who has also kindly volunteered to become part of our panel. Keith is a retired police officer and detective; a neighbourhood watch co-ordinator and a road steward for the Northwood Residents' Association.

Police Priorities:

The 3 priorities are normally set by each ward panel. However, going forward the Borough Command Unit will set the first priorities with the ward panels setting the other two.

"Safer Neighbourhood Teams will work towards three new priorities. The first priority will be set by the BCU and will be violence related or a violence driver. Ward panels will set a minimum of two local ward priorities.

- Priority 1 This will be set by the Safer Neighbourhood Team to include Violence or drivers of Violence.
 This broad category can include all violence types and can include Gangs, Drugs, Domestic Assaults, Violence against women and vulnerable people, public space safety, alcohol fuelled violence and anti-social behaviour linked violence.
- Priority 2 Local priority to be set by the ward panel crime or ASB issue.
- Priority 3 Local priority to be set by the ward panel crime or ASB issue.

Neighbourhood Watch:

Dave Ludlow has been appointed Chair and Kevin Mepham Vice-chair of Neighbourhood Watch. We welcome Kevin to our January meeting to bring us up to date with their current situation.

Moor Park representation:

Lesley Williams continues to be an observer on our panel. Moor Park is part of Northwood but under the jurisdiction of Herts Police. It is unclear at the moment if they have a Police Ward Panel. An ideal outcome would be that all surrounding wards/boroughs have effective Police Ward Panels and we can share intel.

I have been in contact with Herts police and suggested a meeting.

Hillingdon Safer Neighbourhood Board:

I attended a meeting at the Civic Centre on 29 November 22. Some of the same issues emerged. i.e. general dissatisfaction with some aspects of the police service provided. In particular, the lack of feedback when crimes were reported. This gives the impression to the residents that nothing has been followed up nor resolved.

I check this every morning. My concern is with crime in Northwood and adjacent wards. The incidents and police criticism abound. Without further analysis it is difficult to say if these are valid reports to police or just whinges on social media.

I follow up where I can.

Other:

I met with Gareth Blackburn, Max Christmas, John Usher, and Keith Weston personally.

I have communicated with Andrew Riley and Graham Mann of Northwood Hills Residents' Association. I requested to be allowed to attend their police ward panel and also if one of their panel could attend ours. Andrew replied that he would welcome me to their next WP but attendance on ours depended on their resources at the time.

I also had a video meeting with Malcolm Lucas.
