Ultra-Low Emission Zone

As expected the Mayor of London has decided to expand the ULEZ to outer London so that it MAY apply London-wide from 29 August 2023.

Health Report

Planning Permission Granted

Proposals for the new Hillingdon Hospital got a massive boost at Hillingdon Council's Major Planning Committee on 18 January 2023 when they resolved to grant approval for the plans.

The plans set out a new state-of-the-art facility for the people of Hillingdon and beyond that will support the very best of modern healthcare. The new hospital will have the same mix of services as available now at Hillingdon Hospital, be built in the same location (next to the existing hospital) and services will remain open during construction.

Urgent Treatment Centre (A & E)

The provision of the Urgent Treatment Centre at Hillingdon Hospital has been transferred to the Trust, The Hillingdon Hospitals NHS Foundation Trust, on Thursday 26 January 2023.

The change in provision of the service follows a very recent request from the North West London Integrated Care Board.

THHT announce the launch of their new public website at thh.nhs.uk.

A new design makes content easier to find, with patient support, hospital redevelopment, and news packed full of the latest information. Details about all of the services is still there, but can now also be printed out into a leaflet form at the click of a button. More accessibility tools have been added to change the contrast, links to AccessAble access guides for getting around the hospitals, and each page can now be translated into 100 different languages.

Environment Report

Two items given to L B Hillingdon to sort out:

The housing development beside Craigmore House in Murray Rd is almost completed and verges on both side of the entrance driveway and opposite to it have been trashed. These will need re-instatement. LBH ref 0931-1445-0697-2848

Outside an apartment, Copperbeach House, also in Murray Rd foul drains have spilt evil smelling liquid over the pavements and continue to do so. I anticipate that remedial action will end up as a LBH or Thames Water responsibility rather than the apartment block landlord's. LBH ref 8056-8157-4592-2027

A person caught on camera fly tipping rubbish in the alleyway between the Vets and the Cancer Research shop premises had a series of still picture shots taken from a wall mounted video camera. These were placed on the Nextdoor community forum and bought to my attention. They were then passed to Cllr Henry Higgins and action was then taken. The person concerned was identified from the car registration number as the car was driven into the alleyway and also photographed. Perhaps the persistent dumping of rubbish in this alleyway will cease or reduce now.

The property manager of Goldenacre Estates Ltd had raised concerns about the persistent placement of dustbins against the wall of their property, and our help to relieve the problem was enlisted. It was suggested that the matter be elevated within LBH to the deputy leader of the Council or if that fails to work, that Goldenacre Estates take recourse to legal action.

Woods and Open Spaces Report

22 FRINGEWOOD CLOSE NORTHWOOD

A1.17 states that to be an annexe it must be connected internally. Here it is detached from the main house and only connected externally by a 'glazed link.' The proposed building can also very easily be adapted to be fully self-contained simply by removing the 'glazed link' as all the facilities are already provided to make it self-contained, and it has a separate entrance. (also see DMHD 2 for outbuildings)

Whilst the outbuilding now proposed is smaller than the previous application, at 90 sqm it still well exceeds the guide of a maximum of 30 sqm stated in A1.34.

We are concerned that giving consent will provide a precedent for others on both size and the restrictions on 'beds in sheds' expressed in the Local Plan.

Whilst we sympathise with the applicant and the stated reasons for the proposed development, we must have regard to the possible adverse effect elsewhere of encouraging others even without the same reasons to ask for the same and state this as a precedent.

Note: We wonder whether the change in level to access the garden could be overcome with an external platform lift. Equally, others have installed internal lifts to provide for access to other floors in the house. We say this only because alternatives might be available, and not as part of the grounds for objecting.

18 THE BROADWALK NORTHWOOD

The rear of the house adjacent to the garage shown as a sitting room has already been extended by approx 2m and the kitchen by 4,150m as shown on the proposed plan attached to planning application 485/APP/2014/3912 given consent in 2014. Under the Local Plan extensions on extensions are not supported, and the maximum extension from the original back wall under DMHD 1 B (ii) is 4m.

Therefore, as the main house adjacent to the garage has already been extended, the 4.0m should be taken from the original back wall of the house rather than its current back wall. Local Plan A.18 states that: 'Proposals to extend existing extensions will not be supported.' There is already an existing extension to the rear of the house and of the garage and as any additional consent granted should be no more than 4.0m from the back of the original house, the current application should be for below 4.0m new build, and certainly well below the additional 7.9m requested which is in fact closer to 10.0m from the back of the original house.
